

CAMPSITE « LA PUERTA DEL SOL » INTERNAL REGULATION

1°) Conditions of membership

To be allowed to penetrate, to settle down, and to stay on the natural area of campsite, it is necessary to have been authorized by the administrator there. He has for obligation to watch the good behaviour and the good order of the campsite, as well as the respect for the application of the present internal regulation. The fact of staying on the campsite implies the acceptance of the present regulation and the commitment to conform to it.

2°) Formalities of police

Every person that must stay at least one night on the campsite beforehand has to present to the administrator its identity cards and fill the formalities required by the police. The minors not accompanied with their parents will be allowed only with a written authorization of these.

3°) Installation

The tent or the caravan and the equipment relative to it must be settled in the place indicated according to the directives given by the administrator.

4°) Reception

Opening time:

Hight season: from 9h till 12h30 and from 13h30 till 18h (till 19h on Saturday)

Low season: from 10h till 12h30 and from 15h till 18h.

You shall find in the reception all the information on the services of the campsite, the information on the possibilities of provisioning, the sports installations, the tourist wealth of neighborhood and different addresses which can turn out useful. A special box intended to receive the complaints is at the arrangement of the users. The complaints will be considered only if they are signed, dated, so precise as possible and relating to relatively recent facts.

5°) Royalties

Royalties are paid to the administrator. Their amount is the object of a posting in the entry of the campsite and on the price list which is given to you at your arrival. They are due according to the number of nights spent on the campsite.

The users of the campsite are invited to make the payment of their royalty the day before their departure.

6°) Noise and silence - Animals

A : Noise and silence:

The users of the campsite are insistently asked to avoid any noises and discussions which could bother their neighbours.

Acoustic appliances must be adjusted as a consequence. The locks of doors and chests of cars must be as well discreet as possible.

Any noise is totally prohibited between 22pm and 7 am (see about entertainment and evening events period during hight season).

In case of not respect of silence rules the campsite administrator is allowed to expulse noisy and not respectful holiday makers without refund. Penalty fees might be apply.

B : Animals:

Regarding to the French legislation (Article 211-1 du code Rural et aux décrets et arrêtés ministeriels d'application, Dogs classified in category 1 and 2 (Pitbull...) are prohibited.

Cats and dogs must be wearing collar and be tattooed. Each animal owner should arrive first at the reception to show the vaccination card, up to date.

Animals must be never left free. They must not be left on the campsite, even locked, in the absence of their owners who are legally responsible of them.

7°) Visitors

Having been authorized by the administrator, the visitors can be

allowed on the campsite under the responsibility of the campers who receive them.

The camper who receives them can be asked to pay a royalty as far as the visitor has access to the installations of the campsite. This royalty has to be the object of a posting in the entry of the campsite and on the price list.

The cars of the visitors are forbidden on the campsite.

8°) Traffic and car park of vehicles

Inside the campsite, vehicles have to drive to a 10 kph maximum speed. The traffic is forbidden between 10 pm and 7 am.

Can circulate in the campsite only the vehicles which belong to the campers staying there. The car park does not have to hinder the traffic nor prevent newcomers' installation.

9°) Holding and aspect of the installations

Each is asked to refrain from any action which could damage the cleanliness, the hygiene, the aspect of the campsite and its installations, notably sanitary. It is forbidden to throw waste water on the ground or in trenches. The "caravanners" necessarily have to empty their waste water in the installations foreseen for that purpose.

Household refuse as well as divers waste must be sorted out and put down in the containers which are allocated to them. Containers with glass, plastic and metal packagings, as well as newspapers are situated at the entrance of the campsite "La Puerta del Sol" behind the grocery shop.

The wash is strictly forbidden except in the tubs foreseen in this use. The clothesline of the linen will be made if necessary, in the common dryer. However, it is tolerated till 12 am near shelters, on condition that it is very discreet and does not bother the neighbours. It will never have to be made from trees.

Plantations and floral decorations must be respected. It is forbidden to the campers to plant nails in trees, to cut branches, to make plantations.

Campers are not either allowed to bound their place by their own way, nor to dig the ground. The place which will have been used during the stay must be maintained in the state in which the camper found it at his arrival.

10°) Security

a) Fire

Opened fires (wood, coal, etc.) are strictly forbidden. Stoves must be maintained in good condition by functioning and not be used in dangerous conditions.

In case of fire inform at once the administrator of the campsite. A fire extinguisher is available in the sanitary facility in case of necessity. A case of help of first urgency is to be asked to the administrator.

b) Theft

The administrator is responsible for objects which are confided to him and has a general obligation of surveillance of the campsite. The camper keeps the responsibility of his own installation and has to indicate to the person in charge the presence of every suspect person.

Although the guarding is assured, the users of the campsite are invited to take the usual precautions for the protection of their equipment.

11°) Games

No violent or annoying game can be organized near the installations.

Sanitary facilities can not be used for games.

The children will always have to be under the supervision of their parents.

12°) Dead garage

Campers can leave equipment that is not occupied on the campsite, after agreement of the administrator and only in the indicated place. A royalty the amount of which is posted in the entry will be due for the "dead garage".

13°) Posting

The present regulation is posted in the entry of the campsite and to the sanitary facility. It is given to the customer in his demand.

14°) Malpractice against the internal regulation

In case a resident would perturb the stay of the other users or would not respect the capacities of the present regulation, the administrator will instruct this last one to stop the confusions. orally or in writing if he considers it necessary.

In case of malpractice grave or repeated to the internal regulation and after formal demand by the administrator to conform to it, this one can cancel the contract.

In case of penal malpractice, the administrator can appeal to polices.
